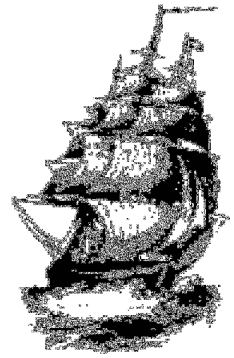


# PEWAUKEE SCHOLARSHIP FUND, INC.
