

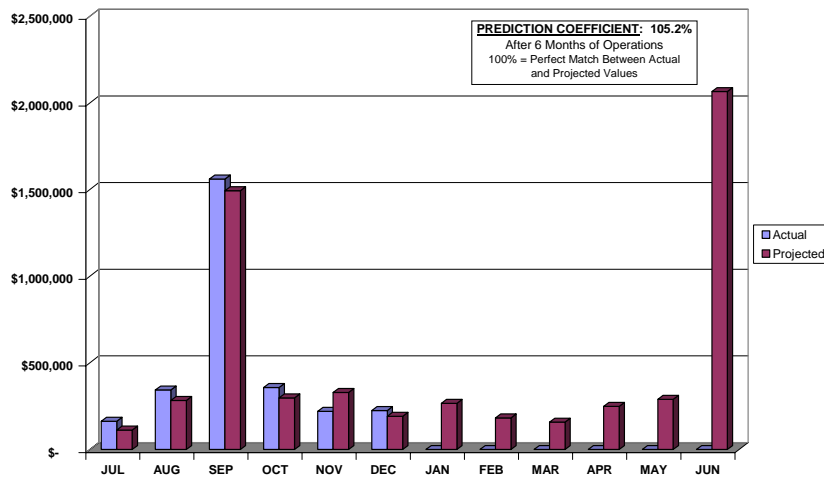
## WINTHROP HARBOR SCHOOL DISTRICT NO. 1 Second Quarter Financial Report FY 2007

The *Summary* Revenue & Expense report for December contained in Attachment A-1 (which uses the straight-line method of analysis) indicates that we are 3% under budget on the revenue side of operations and 3% under budget on the expense side year-to-date (YTD). However, if you refer to Figures 1 and 2 on the following page, the seasonal analysis shows that we are about 5% over budget for revenue, and about 4% under budget for expenses (virtually the same statistics as last month). If you compare this year's month six operations to last year's, we collected \$264,190 more in revenue, but also under-spent last year by \$102,025.

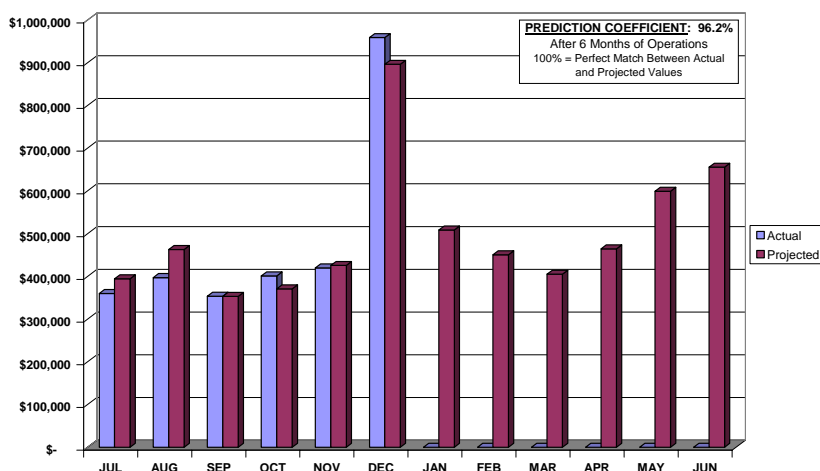
The *Detailed* Revenue & Expense report in Attachment A-1 shows that we received the last trickle of late tax money for the 2005 Levy; now starts the long dry spell until April when we begin to see some early tax money for the 2006 Levy. All other revenue accounts are normal and customary for this time of year.

On the expense side, all of the professional services line items continue to operate well within their expected YTD parameters, and object expenses were about 9% over budget YTD. This overage was solely due to the bond & interest line items, everything else was well within their normal range. If you recall from last month's report, December is always our heaviest month because of large annual bond payments that are made.
